

**in the journal "Sociology of Power"**

1. The author, from the moment of conclusion of this agreement, transfers the validity period published in the journal "Sociology of Power" (hereinafter referred to as the Journal) until publication.
2. In accordance with this agreement, the right to use the article includes
  - 2.1 Announcement (advance notice or public announcement of origin), annotation (summary of contents and related facts) and advertising.
  - 2.2 Use of the article in electronic (digital) form on the Internet with free or restricted access by users.
3. The author guarantees that:
  - 3.1 The manuscript is the original work of the author with co-authors (if any) and has never been published previously in the form presented;
  - 3.2. They have the consent of all the co-authors.
  - 3.3 They will not publish the texts in more than 50% of other printed and (or) electronic documents, except for publications in the form of a preprint;
  - 3.4 The article contains references to cited authors and (or) publications.
  - 3.5 The article does not include materials that are not subject to publication in the open press, in accordance with applicable regulations.
4. The author undertakes:
  - 4.1. To make corrections proposed by reviewers and adopted by the Editorial Board of the Journal;
  - 4.2. Read the proofs within the time limits provided for the schedule for the publication of the Journal;
  - 4.3 The author undertakes not to publish the article text or its fragments in the amount of more than 50% of other printed and (or) electronic publications devoted to publication.
  - 4.4 Introduction of Proof of Article on errors and (or) introduction of factual changes;
  - 4.5. It is not allowed to use the electronic original prepared by the publisher in case of its transfer to the author for commercial purposes and in other publications without the publisher's consent;
5. The publisher shall:
  - 5.1. At its own expense to provide peer review of articles, scientific, literary and artistic-technical editing, the creation of illustrative materials, the manufacture of paper and electronic originals, printing and printing in accordance with the terms of this agreement, as well as the signature campaigns and collection of applications for the circulation of the Journal, including promotional events;
  - 5.2 To coordinate with the author the corrections in the article, taking into account the conditions of paragraphs. 3.4 and 4.1 of this contract;
  - 5.3 Provide the author with the necessary amendments in accordance with the requirements of paragraph 4.5 of this agreement.
6. The publisher guarantees that without the consent of the Author:
  - 6.1. It will not be used as one of the other print and (or) electronic publications;
7. The publisher has the right:
  - 7.1 To print the circulation of the Journal with the Article of the Author upon receipt of additional applications;
  - 7.2 This agreement shall enter into force upon the adoption of a decision by the publisher.

If the Article is not accepted for publication, this agreement shall not enter into force, and the Publisher shall notify the Author thereof within 45 calendar days.
